Modern slavery is a crime and a violation of fundamental human rights. It takes various forms, such as slavery, servitude, forced and compulsory labour and human trafficking, all of which have in common the deprivation of a person's liberty by another in order to exploit them for personal or commercial gain.

We are committed to improving our practices to combat slavery and human trafficking.

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and constitutes Actua's slavery and human trafficking statement for the financial year ending April 2021.

Due diligence processes for slavery and human trafficking

- Mitigate the risk of slavery and human trafficking occurring in our supply chains.

- Protect whistle blowers.

Supplier adherence to our values

We have zero tolerance to slavery and human trafficking. To ensure all those in our supply chain and contractors comply with our values we have in place a supply chain compliance programme.

Our ISO Audit programmes highlight good working practices as well as areas of concern and we will investigate all areas of non-compliance with suppliers, working with them to agree and deliver immediate action to address all issues. We will terminate a supplier agreement where non-compliance is not rectified.

Our compliance is led by a Company Director (Simon Fullard or David Sharp).

Training

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we provide relevant training to our staff (via RICS ethics). We also require our business partners to provide training to their staff and suppliers and providers.
